V. Reports of Standing Committees a. Graduate Policy Committee, J. Standley

Ms. Standley moved for approval for three changes on page 96 of the 1984 Faculty Handbook: 1) change word in title from status to membership, 2) include a new section A, and 3) re-letter a and b to b and c respectively. Her motion was seconded.

After a lengthy discussion, a motion to table was defeated.

An amendment to add the word 'only' to the first sentence under A. Graduate Faculty Status so as to read "Members of the faculty with Graduate Faculty Status <u>only</u> are authorized to teach graduate courses" was withdrawn after some discussion.

Another amendment to add the word 'thereby' to the second sentence of A. Graduate Faculty Status so as to read "They are not thereby authorized to serve on or chair master's and doctoral committees" failed.

The original proposal as included in these minutes as Addendum 1 was approved.

> > Mr. Hodge gave the following figures comparing the University mailroom to the Northwood Mall Post Office.

The University mailroom delivers to 175 departments and 60 buildings.

International mail - By contracting for international mail delivery the University saved \$36,000. Some of the problems with international mail are out of our control, i.e., Italy had a mail strike.

The procedure is that our mail is taken by UPS express to Chicago where it is included with 20 other universities using the same system. It is then taken to Amsterdam. Under the present contract a ten day notice is required to alert the company that we are dissatisfied with the service. Such a notice was issued on September 16. There have been no formal complaints since that time. If you have problems, report these to B. J. Hodge or Walter Bulter.

Please be reminded that we have a University mailroom, not a United States Post Office.

ADDENDUM 1

TO: Faculty Senate

FROM: Graduate Policy Committee

The Graduate Policy Committee has approved and recommends the following addition to P. 96 of the 1984 Faculty Handbook as a new Section A. The sections for Master's and Doctoral Directive Status would be redesignated B and C, respectively. (New material is underlined).

## Graduate Faculty Membership

Any member of the instructional faculty of the University may be considered for membership on the graduate faculty. Membership is determined on the basis of the individual's qualifications.

## A. GRADUATE FACULTY STATUS

Members of the faculty with Graduate Faculty Status are authorized to teach graduate courses. They are not authorized to serve on or chair master's and doctoral committees.

Subject to consideration of special circumstances minimum qualifications are completion of the doctorate or its equivalent and proven expertise in the teaching area.

Under special circumstances qualified persons who are not regular members of the FSU faculty may be accorded Graduate Faculty Status on a temporary basis with the approval of the academic dean and the Dean of Graduate Studies. Under no circumstances does this provision apply to persons holding adjunct appointments to the faculty.

## Rationale

1) This class of graduate faculty status formerly existed at FSU but was not retained when the Graduate School was reorganized.

2) We currently have no graduate faculty status below master's directive level. It is desirable to reinstitute this class since some schools and colleges wish to appoint SACS qualified persons to courtesy ranks for teaching graduate courses and feel these persons are not experienced enough to direct master's and doctoral students. Such persons are qualified for the rank but are hired part-time.
