

V. Reports of Standing Committees
a. Undergraduate Policy Committee, J. Icerman

The following changes to the Faculty Handbook (page 120) on Final Examinations was approved by the Senate:

- 1. No change
- 2. No change
- -3: Omit the entire statement "No-examination-in-lieu-of-a-final examination-may-be-given-in-an-undergraduate-course-during the-final-week-of-elasses-in-any-semester:"
- 3.-4. Change to read "the scheduling of a final examination, or a test in lieu of a final examination, in-the-next-to-the-last week-of-classes-is-construed-to-be-a-violation-of-University policy at any time other than the regularly scheduled final examination period is a violation of University policy.
- 4.-5. No change

Examination Papers

It is University policy that <u>final</u> examination papers of students shall be kept <u>in-the-departmental-file-of</u> by the faculty member giving the examination for one year after the examination is given. Faculty members leaving the University before the completion of the year must leave the examination papers in the departmental files.

b. Curriculum Committee, M. Young

The following information concerning curricular requests was sent to Deans and Department chairmen:

If you are developing or revising courses which you want to include in the 1988-89 University Bulletin (catalog), those courses must be approved by the University Curriculum Committee no later than our March 4 meeting.

The Curriculum Committee will meet four times this semester: January 11, February 12, March 4 and April 15. Course request materials should be received by Janis Sass, 314 WES at least one week prior to each meeting. In planning your timetables, remember that materials submitted to the University Committee must have the approval of all appropriate department or college committees. We urge that you not delay your course requests until the March meeting.

Reminder: As indicated in our last memorandum, courses approved after the January 11 meeting will not appear in the Fall, 1988 Directory of Classes.

Helpful Hint: It is cheaper for departments to purchase course request forms from Office Services than to xerox them.

c. Budget Committee, F. Standley

"The Budget Committee participated with the Steering Committee in a session called by Provost Turnbull of his budget group. Two major subjects were discussed at the session: 1) the potential impact of the repeal of the services tax for the remainder of this academic year as well as next year; and 2) implications for the institution of the proceeds generated by the lottery.

This discussion nexessarily took the form of the speculative and hypothetical "if this happens, etc." None of the options discussed seemed particularly salutary to the overall beneficence of our future as an institution.

The group agreed that we should meet again the latter part of this month or early next month when we would hopefully have some factual data to consider."

Mr. Pitts added that the proposed BOR salary model is not beneficial to FSU faculty. An important component (faculty rank) is not included in the present formula. He will keep the Senate informed of future meetings concerning this issue.
