- I. Approval of the agenda, January 18, 2023 meeting The agenda was approved as distributed.

#### IV. Report of the Steering Committee - Bridgett Birmingham, Vice-Chair

- Bridgett Birmingham began her report by sharing that the committee has met with ACFS on the topic of the Critical Race Theory Equity, Diversity and Inclusion Survey.
- Bridgett Birmingham also noted there is a BOG meeting on January 24th and 25th where hopefully the results and usage of the surveys will be addressed.
- She expressed their continued concern with the legislative interventions into curriculum, as well as the upcoming policy on post tenure review.
- The political and educational climate of Florida has created an environment where the best prepared scholars may not choose Florida as part of their career path.
- She concluded with the Steering Committee will continue to engage with the administration as well as ACFS and the larger governing bodies about the added burden of the policy placed on faculty.
- **President Chicken** opened the floor to questions. None were posed.

# V. Announcements of the President of the University

- President McCullough began his report by thanking everyone who attended the State of the University Address.
- He shared about the visit from Chancellor Ray Rodriguez on January 9th to see and learn more about the FSU Health Initiative. The Chancellor plans to visit many of the universities in the SUS.
- He continued with an update on FSU Health Initiative. He attended the groundbreaking ceremony
  for the FSU-TMH Medical campus in Panama City Beach. He provided a short progress report on
  the building timelines and the funding of those buildings.
- President McCullough shared more on FSU Health Tallahassee. They have picked a location and committees have been formed to help design the building and as well as design the programs.
- He continued with a new Chief Marketing Officer, Susanna Wellesley, joined the FSU team to help with brand strategy to help build international and national reputation.
- President McCullough concluded with noting an Interim Dean has been appointed for the College of Medicine. There are still Dean searches for the College of Communication and Information, and the College of Social Work.
- **President Chicken** opened the floor for questions.
- **President Chicken** asked for clarification of the Governor's request for DEI.
  - **President McCullough** the Institutional Research team has spent time pulling and putting together data. The complications of this report understanding their definitions. President McCullough asked if Carolyn Egan had any details to share.
  - Carolyn Egan, General Counsel stated the numbers were in the hundreds of thousands of dollars of the state money being used, omitting research, and working with the definitions provided.
  - **President McCullough** all this information has been passed on to the Chancellors office to report the data to the state.
- **President Chicken** inquired if they expect any difficulty in funding these courses since we aren't supposed to use state money on these courses.
  - **President McCullough** given the numbers are not tremendous, he doesn't see this as being an issue. He believes the state was looking for where universities may have been diverting funds to these specific programs when they could have been used elsewhere.
- President Chicken can clarification be provided on how many courses will be reported to the BOG.
  - Carolyn Egan, General Counsel stated she will be reporting those courses within the next hour to Matthew Lata with UFF.
- **President Chicken** shared the concern about reporting there are few classes under these definitions, because he feels they are truly valued by students and staff.
  - **President McCullough** noted they tried to follow the definitions as they were provided and as they changed.
- **President Chicken** asked for confirmation whether Faculty names were provided in these reports, as the media raised concerns on that subject.
  - Carolyn Egan, General Counsel confirmed, no names provided.
- Kay Jones, College of Arts and Sciences asked for clarification on the word "equity" as the concern about it.
  - **President McCullough** stated it seems some people believe equity means if one student in a class is an A student and one student is a C student, then they both get a B.
  - He noted he tries to explain that the definition of equity is providing equal opportunity for all students to have the same chance to achieve their goals.
  - He concluded with that he is not uncomfortable with the report that FSU provided. Diversity is a pathway to excellence and FSU doesn't plan on making any changes to that. If the state removes the funding from these programs, FSU will find another way.
- Matthew Lata, United Faculty of Florida reported hearsay of a supplementary request has been made by the State, asking for names in the report, and asked if this was going to be happening.
  - President McCullough noted he had not heard of this.

- Carolyn Egan, General Counsel stated she has heard that the House of Representatives did make a subsequent request, which asked for a list of all current and other DEI employees. The list should identify each person by name and job title, with a due date of Feb. 13.
- Roxanne Hughes, Natl High Magnetic Field Lab could like clarification if post-tenure review was on the agenda for the BOG meeting.
  - **President Chicken** noted he looked at the BOG website and it was not on the agenda.
- **President Chicken** opened the floor to questions. None were posed. He thanked President McCullough and Carolyn Egan.
