II. Approval of the Minutes, April 18, 2018 meeting

The minutes of the April 18, 2018 meeting were approved as distributed.

III. Approval of the agenda, September 12, 2018 meeting

The agenda was approved as distributed.

IV. Special Order: Remarks by the Senate President, Dr. Todd Adams

- Each September the Faculty Senate President is able to give remarks about the upcoming Faculty Senate year. The review of the Faculty Senate Constitution will continue in its third year. Be prepared to hear differing views and opinions regarding constitution revisions.
- The Senate will receive a report today from the Koch Subcommittee.
- Adams occasionally hears from faculty wondering what it is the Senate does and why it is important. The smooth operations of this large university depend on administration, faculty,

staff, students, alumni, and Board of Trustees, who all work together. The role of faculty is not simply to teach students and do research. Faculty play an important role in setting the policies the university operates under, particularly on academics, which is known as shared governance. There was a great example of shared governance last semester while FSU was undergoing a five-year SACS review. FSU is currently undergoing a ten-year accreditation period and this was the mid-review. In preparation for this review, the administration noticed changes needed to be made to the combined/dual degree programs. The Provost's Office and several Senate committees revised FSU's policy on combined/dual degree programs. The policy was passed in the Faculty Senate during spring 2018. This was an example of how the work the Faculty Senate and its committee members do is important.

- It was mentioned last year to have more discussions during meetings and that was followed through adequately, so continue to have discussions during this year.
- For technical purposes it was mentioned that the meetings are recorded and attendees were asked to state their name and affiliation clearly and loudly so they can be properly recognized for the transcribing of the minutes.
- Resolutions can be brought in front of the Senate. The preferred method of submitting a resolution is doing so a couple weeks in advance so the steering committee will know, it can be put on the agenda, and will be sent out to members in advance.
- President Adams closed by saying he thinks it will be a great year and is looking forward to working with everyone.

V. **Report of the Steering Committee, Dr. Kristine Harper**

- The Faculty Senate Steering Committee has met 11 times since the last Faculty Senate meeting in April. The Steering Committee has been filling Faculty Senate committee seats and nominating faculty members for seats on other university committees upon request. In the first meeting of this senate, the committee met with Provost McRorie and VP for Faculty Development and Advancement, Janet Kistner, to discuss the status of hiring for this academic year and the status of dean searches – the College of Education and University Libraries both have new deans on board and will be invited to introduce themselves to the Senate at future meetings. The search for the Dean of Fine Arts is on-going. Provost McRorie discussed the Provost's Postdoctoral Fellowship Program, emphasizing the strength of the diversity piece and the hope to make it a network within the ACC. Provost McRorie has also taken on the role of being chair of the Florida system provosts.
- The committee also met with President Thrasher and Provost McRorie to discuss a variety of topics including campus safety, budget planning, and the Raise the Torch campaign.
- The committee met with Robby Fuselier, Director, Office of Distance Learning and Dr. Liz Jakobowski, Chair, University Curriculum Committee to discuss the review/renew schedule for on-line courses. Since the introduction of on-line courses, these have been reviewed and renewed at various time intervals, a process that requires a considerable amount of work and needs to be revisited. After further consideration, the committee decided to postpone the reviews starting in summer 2018 and extending through fall 2019 for one year. During that time the committee will figure out a better schedule and method for carrying out the reviews. A relevant memo was on the table out front and Senators should have picked up a copy of that (**see Addendum 1**).
- The committee met with Chief David Perry to discuss safety training and hopes to expand how much training faculty receive. [Quick question, do you as faculty want more safety

training? If you have specific topics you would like covered, let one of us know and we will pass that on.]

- The committee also met with Assistant VP for University Communications, Browning Brooks, and Director of Creative Services, Tony Archer, for a briefing on on-going branding efforts. Senators recently received a survey via e-mail asking for faculty input for faculty – please contribute. Your feedback is important.
- Graduate School Dean Mark Riley came to discuss his vision for graduate education. Dean of Undergraduate Studies Karen Laughlin met with the committee to discuss the new honors program, and liberal studies and E-series courses. We will hear more about the honors program from its new director, Dr. Annette Schwabe, later this semester. Dr. Jim Fadool, Chair of the Liberal Studies Coordinating and Policy Committee, will also be giving a report in the upcoming months on possible changes to Formative Experience opportunities.
- The chair and deputy chair of the Constitution Review Committee discussed their progress and plans to bring a final proposal to the Senate this year. There will be a presentation from that committee later in this meeting as well as an update from the Koch Subcommittee.
- On the Elsevier front, several conversations have taken place with Elsevier representatives, library representatives, and Provost McRorie since the end of the spring semester. So far those discussions have not been encouraging, but they will continue through this semester. During 2018, we are subscribing to \$2 million worth of Elsevier journals, but starting in January 2019, we will subscribe to \$1M of the most important journals (as determined by usage data and consultations with departments and faculty members). If Elsevier gets serious in negotiations, then we can change course. Mid-October is the point of no return...so just a little over a month away.
- In the meantime, the library is developing a new expedited delivery service for faculty and graduate students for near instantaneous delivery of journal articles from canceled journal subscriptions. It should be operational later this semester. If Elsevier comes through with better terms, we'll use the system for other canceled journals or journal packages.
- As the committee has discussed in the past, several million dollars of unmet faculty needs have been stacking up for a while. The library has refreshed the list of faculty requested resources that are highly desirable but currently unavailable. These are materials that are considered essential to support new areas of the curriculum and/or of research. If you or your colleagues have such needs and/or would like to see what has been requested in your discipline so far, please contact your subject librarian. The hope is to purchase some of these items with money left over from reducing spending on Elsevier journals.
- The communication and cooperation between faculty members and the University Libraries about unsustainable spending on Elsevier Journals has been on-going for the past year, and the committee continues to work to achieve a consensus solution in the best interests of the university. Be advised that library personnel have been talking to other research institutions throughout the summer, and FSU administration and faculty members have demonstrated leadership on the issue of breaking big deals with STEM journal publishers – we are very much part of a national and international movement. Thank you for participating in this effort.
- On another note, the October Faculty Senate meeting will be held at the University Center Club and a reception for Senators will follow. Stay tuned for more information.

VI. Report of Standing Committees

- Torch Awards Committee, Dr. Jayne Standley
 - a. It is time to begin nominations for the Torch Awards. A memo will come from the Provost's office regarding information about the awards. This was turned into a standing committee last year from an ad hoc committee that began in 1996. This will be the 22nd year of the awards. The purpose of the awards are to allow the faculty to honor people who have made a significant and sustained contribution to FSU's academic mission. The nominations are reviewed by the Torch Awards Committee and submitted to the steering committee for their selection. Winners are given in the name of FSU faculty by the Faculty Senate. This is a Faculty Senate committee award. The award is given in three areas: *vires*—indicating moral, physical, and intellectual strength, *artes*—recognizing appreciation of aesthetics and beauty, and *mores*—acknowledging respect for customs, character, and traditions. The criteria for the nominees is 1) to have an outstanding contribution above and beyond doing a job of what is expected; 2) be living, as the committee does not give posthumous awards; and 3) must not be on the university payroll at the time of the nomination. A prior faculty or staff member would be eligible for nomination. The deadline for nominations is October 1, 2018. Nominations can be sent to Jayne Standley or the co-chair via email.

VII. Old Business

- a. **Constitution Revision Subcommittee, Dr. Joe Calhoun, Chair**
 - Gary Tyson was the former committee chair. Tyson is currently on sabbatical and the committee nominated Calhoun to be chair for this year. The constitution review is being done in three phases. Phase one is complete and contained the technical changes. Technical changes included outdated terminology, such as the Board of Regents to the Board of Trustees or the Board of Governors as appropriate. Phase one changes were approved last year. The committee is in the process of phase two, working on the substantive changes. Phase two includes changes to how things are currently done by the senate, updating those processes, and includes changes the Senate wants to make. The committee is currently working on a section, *crediting of time toward tenure*. There is currently a clause in the Constitution that states a faculty member appointed the rank of assistant professor may receive credit at the time of appointment for up to but no more than two years spent in a tenure-earning position elsewhere. This clause is restrictive and most departments do not operate under this clause. Calhoun gave an open-invitation for Senate members to send their requests for any changes to the constitution to be reviewed by the committee. Requests can be sent by email to him (jcalhoun@fsu.edu) or to any other committee member. The phase two plan includes bringing the proposed changes in October, the next Faculty Senate meeting. This will allow one month before voting on phase two in November. By emailing proposed changes during the next few weeks, this will create a more efficient proposal in October. The changes and amendments will then be added to the proposal to be voted on in November. If needed, the vote will move to December. Phase three will include who is allowed to serve on the Faculty Senate, who is allowed to vote for Senators, and similar issues. This proposal for phase three will be discussed during the December meeting. In preparation for this discussion, Vice

President Kistner will give a faculty report of where people are from for all of the colleges and what kinds of faculty there are from the colleges. Additionally, a minimum of two town-hall meetings will take place. The first will be on a Wednesday, during the conventional 3:30 time for people on this side of campus. The other meeting will take place during a Tuesday or Thursday on the west side of campus to make it convenient for those people to attend. These town-hall meetings will be informal and no formal proposal will be available. When the dates and times of the meetings are formalized, all faculty will receive an email. The goal is to have a formal proposal for phase three for the Senate in December, and then vote on it in January. The goal for the committee is to finish all three phases by the end of the current academic year (2018-2019) with this group of Senators.

- **Erin Ryan, Law** – She requested a way to access the working Faculty Senate Constitution as it stands now. Calhoun reminded the Senate that the phase one changes are not online and officially part of the constitution yet because the revisions have to go through many approvals including the Board of Trustees. A most recent version of the Faculty Senate Constitution with the phase one changes will be posted on the Canvas website.
- **Kathryn Jones, Biological Sciences** – She asked a question regarding Board of Trustees approval. Calhoun responded that it is unlikely that a version of the Faculty Senate Constitution, approved by the Faculty Senate, will make it to the Board of Trustees to then be denied. President Adams clarified that at the President and Board of Trustees level, they can only say yes or no, they cannot request specific changes.
- **Jayne Standley, Music** – She sought clarification for the data report from Vice President Kistner. Since faculty are frequently classified in many different ways, she wanted to know how the reports would show faculty classifications. Vice President Kistner responded that the reports will include tenure-track, specialized, and research faculty. The reports will be as detailed as possible. The reports will not simply list a yes or no to classification as tenure-track faculty.
- **Nancy Rogers, Music** – She sought clarification for the phase two changes and the Board of Trustees regarding the process for requesting changes to the constitution. Calhoun responded that in October, changes can still be requested for the November vote. It was stated that the committee will have the General Counsel review changes before sending the constitution to the Senate to vote on.
- **Jack Fiorito, Business** – He sought clarification regarding the review by General Counsel. Calhoun clarified that they will review the document to look over compliance aspects that may be superseded by other documents.
- **Michael Buchler, Music** – He sought further clarification regarding the General Counsel review and the Collective Bargaining Agreement. Calhoun responded that the changes that were added last time regarding Collective Bargaining and the phrase that Jack added are still in the Constitution. The purpose of the General Counsel review is to make sure the document is in compliance with the University and that the language is relevant.
- **Lynne Hinnant, Communication & Information** – She inquired about the process to have the Faculty Senate Constitution reviewed and approved. Calhoun responded that after the Faculty Senate approves the revised constitution, the university faculty, as

defined by the current constitution, vote, then the President and the Board of Trustees. Each of these votes are a yes or no; they cannot make changes to the document. This vote will take place after all three phases of revision as to make the revision and voting process efficient.

- **Joe Calhoun, committee chair** – The committee would like to get these revisions and phases completed and voted on by the end of this academic year. March will be the last time the current Senate will be able to vote on changes.

b. Koch Subcommittee, Anne Rowe, Chair

- a. The report of the committee was sent to the Steering Committee on September 4, 2018. The committee is comprised of eight members and met seven times between August 2017 and August 2018. The committee reviewed a large number of documents and agreements. They also reviewed the current memorandum about donations and the FSU Foundation and made recommendations. Committee members in the room were recognized and stood up so they could be later contacted if Senators had any questions.

VIII. New Business

a. Senate Committee Membership, President Todd Adams

- A memo was available as people walked into the meeting (**see Addendum 2**). The names highlighted in yellow were new members for those committees. Per the Senate bylaws, the steering committee appoints members with the official consent of the Senate.
- The steering committee made a motion to approve the members and it was seconded. *The nominations for committee memberships were unanimously approved.*
- The remaining appointments for committee memberships available are ongoing. These are expected to be completed by the next meeting. It was requested that those interested in joining a committee email President Adams.

IX. University Welfare

a. Road Scholars Committee, Dr. Dennis Moore

- The committee is beginning its 5th year and this will be the 21st luncheon series. October 5, 2018 will be a presentation from Dr. James Johnson from Chapel Hill (**see Addendum 3**).
- Suggestions for speakers from other ACC institutions were requested.

b. United Faculty of Florida-Florida State University Chapter, Matthew Lata, President

- Over 40 new members were recruited at the new faculty orientation in August.
- This year a full book of contract negotiations will take place. All articles will be open for discussion. To support these discussions, bargaining forums for members will take place. The first forum will be September 14, 2018 from 4:00-5:00pm in the Bellamy building.
- The next item UFF-FSU will be involved with is the election. UFF advocates for issues affecting higher education, not specific candidates. The deadline to register to vote is October 9, 2018. The election is November 6, 2018.
- **Unknown** – Teachers in Florida have to have over 50% for membership. He then asked an inaudible question.

X. Announcements by Deans and other Administrative Officers

a. Janet Kistner, Vice President for Faculty Development and Advancement

- President Thrasher is chair of the ACC Council of Presidents. The ACC presidents were hosted yesterday and today. The President of Botswana will be coming to FSU next week. He is an alumnus of FSU and is stopping by while in the U.S.
- The Raise the Torch campaign will celebrate its \$1 billion capital campaign next week.
- Florida State University is number 26 among public universities according to the U.S. World Report. FSU has been striving to reach the top 25. In 2016, FSU was ranked 43. On behalf of President Thrasher, Kistner thanked the faculty for their efforts in contributing to this rise in ranks. Among those efforts included the rise in smaller student-faculty ratio classes. Further, the Provost and her team strategized how to move forward and have done an excellent job. One of those decisions was the Provost making 125 new faculty positions. A record number 240 new faculty members were welcomed in August.
- The *Faculty Matters* newsletter by the Office of Faculty Development and Advancement has an article on welcoming new faculty members. The newsletter mentions two workshops on mentoring, both on September 28, 2018. The newsletter can be found at fda.fsu.edu/newsletter.
- In spring 2018, faculty were asked to take a satisfaction survey about life at FSU and their work environment. This is done by COACH, Collaborative On Academic Careers in Higher Education. The results were recently received and will be disseminated soon. The results were positive. Kistner will try to come to a future Senate meeting and discuss the results.

The Faculty Senate Steering Committee has temporarily suspended the requirement for distance learning courses to be renewed every three (3) years. This suspension initially applies to the summer 2018 through Fall 2019 terms. During this period, the Senate policy related to renewing distance learning courses will be reviewed and modifications will be considered.

As a consequence of this suspension, all deadlines for regular renewals scheduled for this period that are not already completed will be postponed for one year.

Following the review of the Senate policy, guidelines for future renewal schedule will be developed.

Note, new courses and courses with significant curriculum changes will still need to be reviewed this year. Special topics courses require renewal each term and will not be eligible for the extension.

Faculty Senate Standing Committee Appointments for FS Approval 9/12/2018

Honors Program Policy Committee (Split into 3 terms)

Nine faculty members needed for staggered 3 year terms appointed by the Steering Committee; Steering Committee appoints Chair; no college or school shall have more than 3 faculty representatives.

Bylaws on the Honors Program Policy Committee: The Honors Program Policy Committee shall consider curriculum and related policies and procedures for the University's Honors Program and Honors in the Major Program. The Committee shall consist of nine faculty members appointed by the Steering Committee, with the advice and consent of the Senate, for staggered three-year terms. The Dean of Undergraduate Studies, or his or her designee, and the Director of the University Honors Program shall be ex-officio members. The President of Student Government shall appoint annually two undergraduate students from among present or past participants in a Florida State University honors curriculum.

The chairperson shall be appointed by the Steering Committee from the faculty representatives. The Committee will make its recommendations to the Steering Committee, which will transmit the recommendations to the Senate for action.

Liberal Studies Coordinating Committee

Bylaws on the Liberal Studies Coordinating Committee: The Liberal Studies Coordinating and Policy Committee shall promote liberal education and provide oversight for the liberal studies curriculum. The Committee shall consist of nine faculty members, appointed by the Steering Committee, who shall serve

for staggered three-year terms, including one representative each from the Undergraduate Policy, Honors Program Policy and University Curriculum Committees. The Dean of Undergraduate Studies and Provost and Executive Vice President for Academic Affairs or their designee shall serve as ex-officio members. The Committee may invite to its meetings representatives of administrative offices and others with responsibility for implementing policies that have direct bearing on the Liberal Studies program. The Steering Committee shall appoint the chair annually from among the faculty representatives.

Bylaws on UPC: The Undergraduate Policy Committee shall consider University-wide policies on undergraduate academic affairs. Members of this Committee shall be appointed by the Steering Committee, with the advice and consent of the Senate, for staggered three-year terms. Each college shall have a representative; the Colleges of Education, Business, and Social Sciences shall have one additional representative; and the College of Arts and Sciences shall have four additional representatives. The Provost and Executive Vice President for Academic Affairs, or his or her designee, and the Dean of Undergraduate Studies, or his or her designee, shall be ex-officio members. The President of Student Government shall appoint an undergraduate student member annually.

The Committee shall elect its chairperson annually from the faculty representatives. The Committee will make its recommendations to the Steering Committee which will transmit the recommendations to the Senate for action.

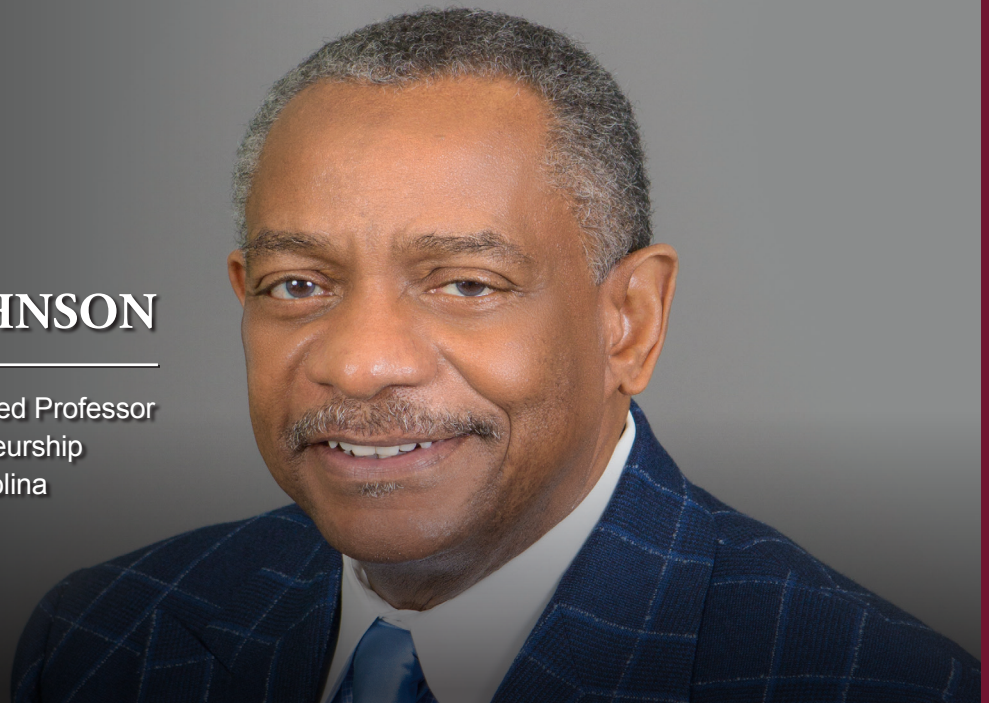
